## SECTION ONE: AUTHORITY

A. Pursuant to 2 N.N.C. $\S 500$, the Resources and Development Committee was established as a standing committee of the Navajo Nation Council.
B. Pursuant to 2 N.N.C. $\$ 501$ (B) (2) (a), the Resources and Development Committee grants final approval for all Rights of Way.

## SECTION TWO. FINDINGS

C. Emery Telecon/Transcon Environmental, Inc., Salt Lake City, has submitted a right-of-way (ROW) application for Utah Education Network (UTEN) San Juan Phase 1 Fiber Optic Project on, over and across Navajo Nation Trust Lands in Aneth Chapter vicinity (San Juan County, Utah). The application request is attached hereto and incorporated herein as Exhibit E.
D. The proposed right-of-way is described in map and description attached hereto and
incorporated herein as Exhibit B.
E. State of Utah Department of Transportation, which is the right-of-way permit holder, "has agreed to approve the permit application to install fiber along UDOT's right-ofway (ROW) through the Navajo nation, along SR 162, in the vicinity of Montezuma Creek. The State of Utah Department of Transportation memorandum dated May 2, 2019 is altached hereto as Exhibit C.
F. The environmental studies and archacological clearances, including the Finding of No Significant Impact (FONSI), are attached as Exhibit D.
G. Aneth Chapter resolutions supporting the Utah Education Network (UTEN) San Juan Phase 1 Fiber Optic Project are attached as Exhibit F.
H. The application for the Right-of-Way as submitted by the Emery Telecon/Transcon Environmental, Inc., has been reviewed Executive Official Review process, including review by the Department of Justice and "Approved" or found "Sufficient.". See documents included in Executive Official Review Document No. 013152, attached as Exhibit G.
