

**BE IT ENACTED:**

**Section One. Authority**

A. The Navajo Nation Council established the Resources and Development Committee as a Navajo Nation Standing Committee.

**Section Two. Findings**

- A. The Resources and Development Committee shall consist of six members. 2 N.N.C. § 500 (A) – (B).
- B. The Resources and Development Committee's Chairperson and Vice-Chairperson shall be selected by a vote of the Resources and Development Committee. 2 N.N.C. § 184 (A).

**Section Three. Confirming Chairperson and Vice-Chairperson**

The Resources and Development Committee of the Navajo Nation Council, pursuant to its authority under Navajo Nation law, hereby confirms \_\_\_\_\_ as Chairperson and \_\_\_\_\_ as Vice-Chairperson.
