18	Section One. Authority	
19	A. The Naabik'íyáti Committee is established as a standing committee of the Navajo	
20	Nation Council. 2 N.N.C. §700(A).

22	Section Two. Findings	
23	A. Standing committees are required to select a member to serve as a Shareholder	
24	Representatives or Member Representatives for certain Navajo Nation enterprises.	
25	B. The By-Laws of Navajo Times Publishing Company, Inc. state, "[a]s a sole shareholder,	
26	the Navajo Nation's shares in the Corporation shall be exercised by five (5) 'shareholder	
27	representatives' comprised of one member from each of the five (5) standing committees	
28	of the Navajo Nation Council or their successor committees"	
29	C. The Naabik'íyáti Committee is permitted to designate one member representative to the	
30	Navajo Times Publishing Company, Inc., as a shareholder representative.
