BE IT ENACTED:

**SECTION ONE. AUTHORITY**

The Naabik'iyáti' Committee of the Navajo Nation Council is a standing committee of the Navajo Nation Council. 2 N.N.C. § 700.

**SECTION TWO. FINDINGS**

A. The Naabik'iyáti' Committee of the Navajo Nation Council established the Naabik'iyáti' Committee Title II Reform Subcommittee through Resolution NABIF-9-15, on February 19, 2015. See Exhibit A.

B. The Title II Reform Subcommittee is to be composed of two members from each Navajo Nation Standing Committee. See Exhibit A, Section Two (B).

**SECTION THREE. APPOINTMENT**
