

WHEREAS:

1. Pursuant to 2 N.N.C. §164 (A)(16) "[m]atters constituting an emergency shall be limited to the cessation of law enforcement services, and disaster relief services, fire protection services or other direct services required as an entitlement under Navajo Nation or Federal law, or which directly threaten the sovereignty of the Navajo Nation. Such an emergency matter must arise due to the pressing public need for such resolution(s) and must be a matter requiring final action by the Council."
2. The Navajo Nation offers this supporting resolution as an emergency in order to support all aspects of providing emergency relief services including, preparedness, mitigation, response, and recovery.
3. A matter concerning the operation of either the House of Representatives or Senate alone is initiated by a simple resolution. A resolution affecting the House of Representatives is designated "H.Res." followed by its number. They are not presented to the President for action.

- 1 4. This House Resolution will allow for additional relief for citizens of the United States,
2 including members of the Navajo Nation facing impacts from COVID-19.
3 5. COVID-19 is a serious respiratory disease that can be fatal. The disease is pandemic and
4 rapidly spreading throughout the United States. Moreover, the first cases of COVID-19
5 have been reported on the Navajo Nation.

7 NOW THEREFORE BE IT RESOLVED:

8 The Navajo Nation hereby supports H RES. _____, "Directing the Clerk of the
9 House of Representatives to make corrections in the Engrossment of H. R 6201."
