25	B. The By-Laws of Navajo Times Publishing Company. Inc. state, "[a]s a sole
26	shareholder, the Navajo Nation's shares in the Corporation shall be exercised by five
27	(5) 'shareholder representatives' comprised of one member from each of the five (5)
28	standing committees of the Navajo Nation Council or their successor committees"

- C. Through Resolution HEHSCMA-03-19 the Health, Education and Human Services Committee appointed Delegate Paul Begay, Jr. to serve as shareholder representative to the Navajo Times Publishing Company, Inc.
- D. On July 24, 2019, Delegate Paul Begay, Jr., by memorandum requested to be released from his assignment as shareholder representative to the Navajo Times Publishing Company, Inc. The July 24, 2019 memorandum is attached as Exhibit A.
- E. On March 3, 2020 Navajo Times CEO/Publisher Tom Arviso, Jr. wrote the Chairman of the Health, Education and Human Services Committee requesting that another member of the Health, Education and Human Services Committee be appointed as Shareholder Representative.
