

19 **SECTION ONE. AUTHORITY**

20 **A** The Resources and Development Committee of the Navajo Nation Council is a  
21 standing committee of the Navajo Nation Council exercising oversight authority over  
22 water, land, grazing and environment. 2 N.N.C. § 500 (C).

23 **B.** The Naabik'iyáti' Committee of the Navajo Nation Council is a standing committee  
24 of the Navajo Nation Council. 2 N.N.C. § 700.

25  
26 **SECTION TWO. FINDINGS**

27 **A.** The Naabik'iyáti' Committee of the Navajo Nation Council established the  
28 Negotiation Subcommittee for the Completion of the Navajo Nation Indian Irrigation  
29 Project (NIIP) April 13, 2017 through Resolution NABIAP-38-17. See Exhibit A.

1 B. The Subcommittee is composed of five (5) members of Council, one from each of the  
2 Standing Committees appointed by, and serving at the pleasure of, the Naabik'iyáti'  
3 Committee. See Exhibit A.

4 C. The Subcommittee is to negotiate with the United States to develop a Memorandum of  
5 Agreement regarding the funding and completion of the NIIP, advocate for funding and  
6 management of the NIIP, advocate for funding for NIIP under the Water Infrastructure  
7 Improvements for the Nation Act and lobby in the interest of NIIP.

8  
9 **SECTION THREE. APPOINTMENT**

10 The Naabik'iyáti' Committee of the Navajo Nation Council hereby appoints the following  
11 members of the Navajo Nation Council to the Negotiation Subcommittee for the  
12 Completion of the Navajo Nation Indian Irrigation Project:

22 and shall report its recommendations to the Naabik'iyáti' Committee. 2 N.N.C. § 186
