24	empowered to grant final approval for non-mineral leases. 2 N.N.C. §501(B)(2).

26	Section Two. Findings
27	A. DP Mike Enterprise, Inc., dba, Chinle Burger King has requested that the
28	Resources and Development Committee modify its Business Site Lease No. CH-
29	90-86 such that it be governed by the Navajo Nation Business Site Lease
30	Regulations.

1	B. The DP Mike Enterprise, Inc., dba, Chinle Burger King lease is attached as
2	Exhibit B.
3	C. The Lease Modification for DP Mike Enterprise, Inc., dba, Chinle Burger King is
4	attached as Exhibit A.

6	Section Three. Approval
7	A. The Navajo Nation hereby approves the Lease Modification to Novate Lease No.
8	DP Mike Enterprise, Inc., dba, Chinle Burger King CH-90-86 as set forth in the
9	documents as Exhibit A, to be governed by Navajo Nation Business Site Lease
10	Regulations.
11	B. The Navajo Nation hereby authorizes the President of the Navajo Nation to
12	execute this Lease Modification to Novate and all other documents necessary to
13	effectuate the intent of this resolution.
