TITLE OF RESOLUTION: PROPOSED STANDING COMMITTEE RESOLUTION; AN ACTION RELATING TO AN EMERGENCY; EXTENDING THE EXPIRATION OF NAVAJO NATION COUNCIL RESOLUTION NO. CAP-19-20

PURPOSE: The purpose of this legislation is to extend the expiration date of Navajo Council Resolution No. CAP-19-20. The Navajo Nation Council Resolution CAP-19-20 authorized chapter meetings to be held telephonically or through video conferencing; clarified Title 26 sections authorizing chapters to function to meet the needs of their communities during the COVID-19 health crisis under the three-person quorum and the Executive Branch closure of Navajo Nation government offices.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

18	А.	The Navajo Nation Council is the governing of body of the Navajo Nation.

23	C.	Pursuant to 2 N.N.C. §164 (A)(16) "[m]atters constituting an emergency shall	
24		be limited to the cessation of law enforcement services, and disaster relief	
25		services, fire protection services or other direct services required as an	
26		entitlement under Navajo Nation or Federal law, or which directly threaten the	
27		sovereignty of the Navajo Nation. Such an emergency matter must arise due to	
28		the pressing public need for such resolution(s) and must be a matter requiring	
29		final action by the Council."

2	А.	The Navajo Nation President issued Executive Order 001-20 declaring a state of
3		emergency due to COVID-19 on March 13, 2020.
4	В.	On March 11, 2020, the Emergency Management Commission declared a state
5		of emergency due to COVID-19. CEM-20-03-11.
6	C.	The Navajo Nation President issued Executive Order 002-20 on March 31, 2020
7		extending the Declaration of a State of Emergency due to the COVID-19 virus
8		on the Navajo Nation and extending the closure of Navajo Nation government
9		offices and related entities. See Executive Order Nos. 001-20, 002-20, 003-20,
10		and 004-20.
11	D.	The Navajo Department of Health Public has issued Public Health Emergency
12		Orders which have limited public gatherings, imposed Stay at Home Orders,
13		imposed night curfews, 57-hour weekend curfews and 57-hour weekend curfews
14		with closure of essential business all for the purpose of limiting the spread of
15		COVID-19. See Public Health Emergency Order Nos. 2020-001, 2020-003,
16		2020-004, 2020-005, 2020-006, 2020-008, 2020-010 and 2020-011.
17	E.	The Navajo Nation Council passed CAP-19-20 which authorized the Chapters
18		to allow chapter meetings to be held telephonically or through video
19		conferencing; clarified Title 26 sections authorizing chapters to function to meet
20		the needs of their communities during the COVID-19 health crisis under the
21		three-person quorum and the Executive Branch closure of Navajo Nation
22		government offices. Resolution CAP-19-20 will lapse on July 15, 2020. CAP-
23		19-20 and CMY-36-20 overriding the Presidential veto of CAP-19-20 are
24		attached as Exhibit A.
25	F.	The Navajo Nation Council finds that it is necessary to allow Chapters to meet
26		telephonically or through video conferencing to further reduce the spread of the
27		COVID-19 virus. In addition, Chapters must continue to perform particular
28		Chapter functions during the declared State of Emergency to provide disaster
29		relief services to their communities and Chapter officials must function through
30		Chapter meetings to act upon matters affecting the Chapter residents during the

1	COVID-19 crisis. This resolution is necessary to address a pressing public need
2	and is a matter requiring final action by the Navajo Nation Council.
3	
4	Section Three. Extending Expiration of CAP-19-20
5	The Navajo Nation Council hereby extends the expiration of Resolution CAP-
6	19-20 to expire when the public gathering limitation is lifted or changed to
7	allow a minimum Chapter quorum of twenty-five (25) or otherwise determined
8	by the Navajo Nation Council.
9	
10	Section Four. Effective Date
11	The provisions of this Action shall become effective pursuant to 2 N.N.C. § 221 (B).
12	
13	Section Five. Savings Clause
14	Should any provision of the amendments enacted herein be determined invalid by the
15	Navajo Nation Supreme Court or the District Courts of the Navajo Nation, without
16	appeal to the Navajo Nation Supreme Court, the remainder of the amendments shall
17	remain the law of the Navajo Nation.
