18 **SECTION ONE. AUTHORITY**

- 19 A. The Health, Education and Human Services Committee is a standing committee of
20 the Navajo Nation Council. 2 N.N.C. § 400(A).
21 B. The Health, Education and Human Services Committee is the oversight committee
22 for the Navajo Nation Division of Human Resources. 2 N.N.C. § 401(B)(1).
23 C. Each oversight committee shall review and make recommendations to the Budget
24 and Finance Committee concerning the budget in accordance with the annual
25 budget instructions. 12 N.N.C. § 840 (A).

27 **SECTION TWO. FINDINGS**

- 28 A. The Health, Education and Human Services Committee held a budget hearing and
29 took budget testimony regarding the Navajo Nation Division of Human Resources,
30 Fiscal Year 2020 Budget. 12 N.N.C. § 840 (A).

1 B. The Health, Education and Human Services Committee recommends to the Budget
2 and Finance Committee a fiscal year budget for the Navajo Nation Division of
3 Human Resources. 12 N.N.C. § 840 (A).

13 B. The Health, Education and Human Services Committee requests that the Budget and
14 Finance Committee and the Navajo Nation Council adopt the changes to the Budget,
15 as set forth in the General Fund Comparative Summary, **Exhibit B**, Recommended
16 Changes to the General Fund Budget, **Exhibit C**, Recommended Conditions of
17 Appropriation and Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs,
18 **Exhibit E**.
19 C. The Health, Education and Human Services Committee authorizes the Committee
20 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and Finance
21 Committee on these recommendations.
