18 **Section One. Authority**

- 19 1. The Resources and Development Committee exercises authority over chapters of
20 the Navajo Nation. 2 N.N.C. § 501(C)(1).
- 21 2. The Budget and Finance Committee of the Navajo Nation Council exercises
22 authority over budgeting, appropriation, investment and management of all funds.
23 2 N.N.C. § 301 (B)(2).
- 24 3. Council Resolution CAP-35-18 provides, “[a] chapter project, powerline, or
25 waterline project may be changed, including the year funded, or added to Exhibits
26 A through E with the concurrence of the Delegate representing the chapter’s
27 Council District and the approvals of the Resources and Development Committee
28 and Budget and Finance Committee, as long as such project has been certified as
29 construction-ready by CPMD or NTUA and the total Sihasin Funding for the
30 District does not exceed \$4,166,666.67.” **Exhibit 1.** Section Four, Paragraph C.

2 **Section Two. Findings**

- 3 A. The Navajo Nation Council adopted Council Resolution CAP-35-18, "Adopting the
4 Sihasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14,
5 as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12
6 N.N.C. §§ 810 (F), 820 (I) and (M) and 860 (C) Relating to the Capital Budget and
7 Capital Improvement Process" on April 17, 2018, which is attached as **Exhibit 1**.
- 8 B. Round Rock Chapter submitted a CAP-35-18 Project Change Form, which is attached as
9 **Exhibit 2**, and a chapter resolution dated, April 14, 2019, which is attached as **Exhibit**
10 **3**.
- 11 C. The Project Change Form indicates \$228,533.94 will be deleted from Apache County
12 Road Improvement Project C590 Year 3 and added to the Year 2 funding. This will
13 increase the total funding for Year 2 of the project to \$288,533.94.
- 14 D. The Project Change Form indicates \$ 351,153.69 will be deleted from Apache County
15 Road Improvement Project C492 Year 3 and added to the Year 2 funding. This will
16 increase the total funding for Year 2 of the project to \$411,153.69.
- 17 E. For reference, the Project for C590 and C492 is included in **Exhibit 1**, Exhibit D,
18 Projects 35 and 36, respectively.

20 **Section Three. Approval**

21 The Navajo Nation hereby approves a change allowing funding to be deleted from Year
22 3 of the Round Rock Chapter projects and added to Year 2 of the projects in accordance
23 with **Exhibit 2**.
