22	SECTION 1. AUTHORITY	
23	A. The Health, Education and Human Services Committee is empowered HEHSC	
24	to review and recommend resolutions relating to social services. 2 N.N.C. § 401	
25	(B)(6)(a).	
26	B. The Budget and Finance Committee (BFC) is empowered to review and	
27	recommend to the Navajo Nation Council the management of all funds. 2 N.N.C.	
28	§ 301 (B)(2).	
29	C. The Navajo Nation Council established the Naabik'íyáti' Committee as a Navajo	
30	Nation standing committee and as such proposed legislation that requires final	

- action by the Navajo Nation Council shall be assigned to the Naabik'íyáti' Committee. 2 N.N.C. §§ 164 (A)(9) and 700 (A).
- D. When the Controller identifies additional sources of revenues above and beyond the initial or current revenue projections, supplemental appropriations may be allocated by the Navajo Nation Council. 12 N.N.C. § 820(L).
- E. All requests for annual operating funds and supplemental funds shall be submitted to the Office of Management and Budget (OMB) for budget impact analysis. 12 N.N.C. § 820(M).

SECTION 2. FINDINGS

- A. The Division of Aging and Long Term Care Support (DALTCS) has requested a supplemental appropriation of Nine Hundred Fifty-Four Thousand Nine Hundred Seventy-Three Dollars (\$954,973) for Chinle, Crownpoint, Fort Defiance, Shiprock Agency, Tuba City, and Administrative Offices. The budget forms for each office are attached as **Exhibit A**.
- B. The supplemental appropriation amounts requested for each office are as follows:
 - 1. DALTCS- Chinle, BU# 113011, \$222,814
 - 2. DALTCS Crownpoint, BU# 113013, \$189,739
 - 3. DALTCS Fort Defiance, BU# 113012, \$ 77,122
 - 4. DALTCS Shiprock Agency, BU# 113015, \$326,273
 - 5. DALTCS Tuba City, BU# 113014, \$ 123,430; and
 - 6. DALTCS Administrative Offices, BU# 113010, \$15,595.
- C. The Title 12 Finance Act Supplemental Appropriation requirements include:
 - Pursuant to 12 N.N.C. § 820(L), when the Controller identifies additional sources of revenues above and beyond the initial or current revenue projections, supplemental appropriations may be allocated by the Navajo Nation Council. The Office of the Controller has indicated that as of April 10, 2019 the updated balance in the Unreserved, Undesignated Fund Balance (UUFB) is \$42,334,700.00. An updated

- balance from the Office of the Controller was not available at the time of drafting this proposed resolution.
- 2. Pursuant to 12 N.N.C. § 820(M), all requests for annual operating funds and supplemental funds shall be submitted to the Office of Management and Budget (OMB) for budget impact analysis. The OMB budget impact analysis for this legislation was not available at the time of drafting the proposed resolution.
- 3. The Office of Controller memo stating the current balance of the UUFB and whether the allocation is considered a recurring cost was not available at the time of drafting the proposed resolution.

SECTION 3. APPROVING SUPPLEMENTAL FUNDING FROM THE UNRESERVED, UNDESIGNATED FUND BALANCE IN THE AMOUNT OF NINE HUNDRED FIFTY-FOUR THOUSAND NINE HUNDRED SEVENTY-THREE DOLLARS (\$954,973) FOR BUSINESS UNIT NUMBERS 113010-113015

- A. This supplemental appropriation of \$954,973 shall be from that amount of funds that exceeds the minimum fund balance of the Unreserved, Undesignated Fund Balance as determined by the Office of the Controller and to Business Unit Numbers 113010-113015.
- B. The Navajo Nation hereby approves supplemental funding from the Unreserved. Undesignated Fund Balance in the amount of \$954,973 for Business Unit Numbers 113010-113015.
- C. The supplemental funding shall be deposited in accordance with the budget forms in **Exhibit A.**
