23	B. A budget modification is an increase or decrease of \$50,000 or more to an existing	
24	business unit budget in a previously approved budget, which requires oversight	
25	committee approval. Navajo Nation Budget Instruction Manual Fiscal Year 2019,	
26	Section XIII. C. (c).

28	SECTION TWO. FINDINGS	
29	A. The Navajo Nation Insurance Commission and the Navajo Nation Insurance	
30	Services Department have requested Budget modifications in the amount of	

l	\$140,000 and \$18,571,000 for the Employee Benefits Program/Group Health Self-
2	Insurance as found Resolution NNIC-08-12-0019 of the Navajo Nation Insurance
3	Commission. See Exhibit No. 1.
4	B. The Insurance Services Department Employees Benefit Program has prepared
5	budget documents indicating the request for a budget modification. The budget
6	documents are included in Exhibit No. 1, tab A, B and C.
7	C. Budget documents indicate the original budget approved by the Navajo Nation
8	Council for Fiscal Year 2019 was \$19,100,000. Budget modifications of \$140,000
9	and \$18,571,000 respectively will result in a total budget amount of \$37,811,000 for
10	Fiscal year 2019.
11	D. The Executive Official Review is attached at <b>Exhibit No. 1.</b> All reviewers indicated
12	the request for a budget modification is sufficient.

14	SECTION THREE. APPROVAL OF BUDGET MODIFICATION FOR
15	INSURANCES SERVICES DEPARTMENT EMPLOYEES BENEFIT PROGRAM
16	The Budget and Finance Committee hereby approves the requested budget
17	modifications of \$140,000 and \$18,571,000 respectively for a combined requested total
18	increase of \$18,711,000 and thereby increasing the total budget for the Employees
19	Benefit Program/Group Health Self-Insurance to \$37,811,000 as indicated in the
20	budget forms as found within Exhibit No. 1.
