TITLE OF RESOLUTION: AN ACTION RELATING TO RESOURCES AND DEVELOPMENT AND BUDGET AND FINANCE COMMITTEES; APPROVING A PROJECT CHANGE IN RESOLUTION CAP-35-18, EXHIBIT C PROJECT 9, 3 FOR COUNSELOR CHAPTER; APPROVING A CHANGE IN FUNDING FROM YEAR 1 TO YEAR 3; APPROVING A CHANGE IN PROJECT DESCRIPTION

PURPOSE: The purpose of this resolution is to change the project funding year and project description in CAP-35-18 for Counselor Chapter.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

1 **Section Two. Findings**

- 2 A. The Navajo Nation Council adopted Council Resolution CAP-35-18, “Adopting the
3 Sihasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14,
4 as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12
5 N.N.C. §§ 810 (F), 820 (I) and (M) and 860 (C) Relating to the Capital Budget and
6 Capital Improvement Process” on April 17, 2018, which is attached as **Exhibit 1**.
- 7 B. Counselor Chapter submitted a CAP-35-18 Project Change Form, which is attached as
8 **Exhibit 2**. For reference, the Counselor Chapter project is included in **Exhibit 1**, Exhibit
9 C, Project 9.
- 10 C. Counselor Chapter submitted a chapter resolution indicating its support for this request,
11 which is attached as **Exhibit 3**.
- 12 D. Counselor Chapter wishes to move its funding for the project from year 1 to year 3 and
13 to include planning in the project description since the project needs to complete the
14 right of way process.
