16 **Section One. Authority**

- 17 A. The Resources and Development Committee of the Navajo Nation Council has  
18 oversight authority with respect to communications and utilities. 2 N.N.C. § 500(C).  
19 B. The Naabik'iyáti' Committee of the Navajo Nation Council has been empowered to  
20 confirm all appointments to boards and commissions. 2 N.N.C. §§ 700 (A), 701 (A)(1).

21  
22 **Section Two. Findings**

- 23 A. The Navajo Telecommunications Regulatory Commission (Commission) is established  
24 under 2 N.N.C. §§ 3451-3455.  
25 B. The Commission consists of seven Commissioners appointed by the President of the  
26 Navajo Nation and confirmed by the appropriate committee of the Navajo Nation  
27 Council. 2 N.N.C. §3454(A)  
28 C. The appointment to the Commission shall be for a period of four (4) years. 2 N.N.C. §  
29 3454 (B).

1 D. The President of the Navajo Nation has appointed Ms. Nadine Clah to the Navajo  
2 Nation Telecommunications Regulatory Commission for a period beginning October  
3 1st, 2019 and ending September 30, 2023. Appointment letter attached as **Exhibit A**,  
4 letter of interest as **Exhibit B** and resume as **Exhibit C**.

5 E. The Navajo Nation finds it in the best interest of the Navajo Nation to confirm the  
6 appointment of Ms. Nadine Clah to the Navajo Nation Telecommunications Regulatory  
7 Commission for a period beginning October 1, 2019 and ending September 30, 2023.

9 **Section Three. Confirmation**

10 The Naabik'iyáti' Committee of the Navajo Nation Council, on the recommendation  
11 of the Resources and Development Committee, hereby confirms the President's appointment  
12 of Ms. Nadine Clah to the Navajo Nation Telecommunications Regulatory Commission for  
13 a period beginning October 1<sup>st</sup>, 2019 and ending September 30, 2023.
