26	Navajo Nation and confirmed by the appropriate committee of the Navajo Nation

D. The President of the Navajo Nation has appointed Mr. Norbert Nez to the Navajo Nation Telecommunications Regulatory Commission for a period beginning October 1, 2019 and ending September 30, 2023. Appointment letter attached as Exhibit A, letter of interest as Exhibit B and resume as Exhibit C.

E. The Navajo Nation finds it in the best interest of the Navajo Nation to confirm the appointment of Mr. Norbert Nez to the Navajo Nation Telecommunications Regulatory Commission for a period beginning October 1, 2019 and ending September 30, 2023.

## Section Three. Confirmation

The Naabik'iyáti' Committee of the Navajo Nation Council, on the recommendation of the Resources and Development Committee, hereby confirms the President's appointment of Mr. Norbert Nez to the Navajo Nation Telecommunications Regulatory Commission for a period beginning October 1, 2019 and ending September 30, 2023.
