Section Two. Findings

- A. The Navajo Nation Council adopted Council Resolution CAP-35-18, "Adopting the Síhasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14, as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12 N.N.C. §§ 810 (F), 820 (I) and (M) and 860 (C) Relating to the Capital Budget and Capital Improvement Process" on April 17, 2018, which is attached as Exhibit 2 (CAP-35-18 and its Exhibit D).
- B. Ramah Chapter submitted a Sihasin Project Amendment Certification, which is attached as **Exhibit 1**.
- C. The Sihasin Project Amendment Certification, Exhibit 1, indicates that CAP-35-18 Exhibit D, Project No. 12, Ramah Chapter Renovation change the Project Type from "Design/Construction" to "Plan, Design, Construct & Equip. Timeline to 36 months" as shown in Exhibit 1.
