






Are you familiar with the purpose and role of NHA as the Navajo Nation's "Tribally Designated Housing Entity (TDHE)?"




Are you familiar with any studies or reports on housing needs within the Navajo Nation?




Are you familiar with the operation and purpose of NHA?




Are you familiar with the operation and purpose of Navajo Nation Division of Community Development?




Where would you prefer a home to be located?




Do you think family safety is an issue within NHA community housing?

Online (Common Trends)

- Too much red tap to build homes
- Too many deficient homes built
- The Navajo government does not support NHA
- ♦ No lands available for NHA to build homes
- Homelessness is a problem
- Professional and educated people are needed to plan for housing
- NHA only needs improvement, DCD will do a worst job and DCD does not have the capability
- ♦ NHA mismanagement of funds
- Support for community housing

Public Hearing (Common Trends)

- More homes are needed
- NHA does not repair homes
- Homeowners need to take responsibility of their own homes
- DCD does not have the capability to manage NAHASDA funds
- ♦ NHA makes it difficult to get a home
- NHA housing eligibility needs to change

Additional Comments

Online (Common Trends)

- People need transparency from NHA
- Navajo people only want free homes without pay
- Nepotism within NHA
- NHA homes need repairs
- Professional plans are needed
- NHA mismanagement of funds
- NHA is professional and doing great
- ♦ TDHE needs to stay with NHA
- The legislation does not have a plan

Public Hearing (Common Trends)

- No assistance from NHA on home issues
- ♦ NHA needs more community input
- NHA homes need repairs
- Give NHA another chance

Most common verbal public comments December 21, 2016, Navajo Nation Museum

Attendance: 173 people 53 Verbal comments

- Homes should be considered on homesite lease area opposed to scattered homes
- NHA is not repairing homes
- Vandalism of NHA homes is a problem
- No homes available despite completing the NHA process of applying for a home

- No plan in place for transition of TDHE to DCD if the legislation becomes law
- Possible consequences if legislations becomes law and take effect
