C. Regarding Project No. D5, the Capital Projects Management Department ("CPMD") on

behalf of the San Juan Chapter, has requested to delete the "Multi-Purpose Site

Improvement Project" and change the project description to "Road Improvement for

N566 and N361; Plan/Design & Construct" and the change the funding year to Year 3.
