21	B. A proposed resolution that requires final action by the Navajo Nation Council shall be	
22	assigned to the Naabik'íyáti' Committee before it is heard by the Navajo Nation	
23	Council. 2 N.N.C. § 164 (A)(9).	
24	C. The Budget and Finance Committee is a standing committee of the Navajo Nation	
25	Council with the enumerated power to receive an annual audit of the accounts of the	
26	Navajo Nation by certified public accountants and to present such audit to the Navajo	
27	Nation Council. 2 N.N.C. § 301(B)(10).

2	Auditor's Report for the Navajo Nation. The 2020 Financial Statements are attached at

5	B. The Navajo Nation finds it in the best interest of the Navajo Nation to accept the 2020
6	Independent Auditor's Report.
