27	SECTION TWO. FINDINGS	
28	A. The Navajo Nation Council appro	ved Resolution No. CAP-35-18, entitled, "Adopting the
29	Síhasin Fund Powerline and Chap	ter Projects Expenditure Plan Pursuant to CD-68-14, as
30	Amended by CJA-03-18, and 12 N	N.N.C. §§ 2501-2508, as Amended; Waiving 12 N.N.C.

§§ 810 (F), 820 (I) And (M) And 860 (C) Relating to the Capital Improvement Budget and the Capital Improvement Process." CAP-35-18 is incorporated herein by reference. 2 B. Section 4(C) of CAP-35-18 provides: "A chapter project, powerline, or waterline project 3 may be changed, including the year funded, or added to Exhibits A through E with the 4 concurrence of the Delegate representing the chapter's Council District and the approvals 5 of the Resources and Development Committee and Budget and Finance Committee, as 6 long as such project has been certified as construction-ready by CPMD or NTUA and the 7 total Síhasin Funding for the District does not exceed \$4,166,666.67." 8 C. The amount of \$271,666.67 for the Sawmill Chapter N-7 Road Rehabilitation Project in 9 the Year 1 Funding Period was approved in Exhibit D of CAP-35-18. The CAP-35-18 10 Exhibit D showing the N-7 Road Project No. 59 is attached hereto as **EXHIBIT 1**. 11 D. The amount of \$500,000 for the Sawmill Chapter House Renovation Project was also 12 approved in Exhibit D of CAP-35-18. The CAP-35-18 Exhibit D showing the Chapter 13 House Renovation Project No. 58 is attached hereto as **EXHIBIT 1**. 14 E. The Sawmill Chapter has expended \$185,533 out of the \$271,666.67 in approved Síhasin 15 funds allocated for the N-7 Road Project, leaving a remaining balance of \$32,133.67 that 16 the Chapter desires to use for its Chapter House Renovation Project. EXHIBIT 2. 17 F. Regarding the Sawmill Chapter's change request, the Division of Community 18 Development - Capital Projects Management Department ("CPMD") has submitted, on 19 behalf of the Chapter, a Síhasin Project Amendment Certification Form, attached as 20 EXHIBIT 3. The CPMD Amendment Certification Form shows the signature of the 21 Navajo Nation Council Delegate for the Sawmill Chapter, as required by CAP-35-18 22 23 Section 4(C). G. As required by CAP-35-18 Section 4(C), the Sawmill Chapter House Renovation Project 24 to be added has been certified by CPMD as construction-ready and the total Síhasin 25 Funding for the Council District will not exceed \$4,166,666.67. In fact, the total Síhasin 26 funding amounts approved for the Sawmill Chapter in CAP-35-18 will remain unchanged. 27 H. The Síhasin Fund shall be reimbursed, in the amount of the allocation authorized in this 28 Legislation, from prospective funds available to the Navajo Nation from any and all 29 appropriate state and federal sources. 30

#### SECTION THREE. APPROVAL

The Navajo Nation Council hereby approves a change to Resolution No. CAP-35-18, Exhibit D, Project Nos. 58-59 by transferring the balance of \$32,133.67 remaining from the N-7 Road Rehabilitation Project (Project No. D-59) to the Sawmill Chapter House Renovation Project (Project No. D-58) in the Year 2 Funding Period, as shown in **EXHIBIT 3**.

### SECTION FOUR. EFFECTIVE DATE

This Legislation shall become effective pursuant to 12 N.N.C. §2505.

### SECTION FIVE. SAVING CLAUSE

If any provision of this Legislation is determined invalid by the Supreme Court of the Navajo Nation, or by a Navajo Nation District Court without appeal to the Navajo Nation Supreme Court, the provision(s) not determined invalid shall remain as Navajo Nation law.
