19	SECTION ONE. AUTHORITY	,
20	A. The Law and Order Committee ("LOC") is a standing committee of the Navajo Nation	
21	Council with oversight authority over the Judicial Branch. 2 N.N.C. §600(A); 2 N.N.C.	
22	§601(C)(1).	
23	B. Each Oversight Committee, including the LOC, shall review and make recommendations	
24	regarding the programs under its oversight responsibility, regarding the Navajo Nation's	
25	Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C. §840(A).

27	SECTION TWO. FINDINGS	
28	A. In accordance with 12 N.N.C. §840(A), the LOC held hearings and took relevant testimony	
29	regarding the FY2023 Budget for the Office of Hearings and Appeals.	
30	B. During these budget meetings, the LOC reviewed and considered the proposed FY2023	

1	Budget for the Office of Hearings and Appeals, as commented upon by members of the
2	public.

4	SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET AND
5	FINANCE COMMITTEE THE FISCAL YEAR 2023 BUDGET
6	FOR THE OFFICE OF HEARINGS AND APPEALS AND
7	RELATED MATTERS
8	A. The Law and Order Committee hereby approves the FY2023 Budget for the Office of
9	Hearings and Appeals, as detailed in the "Fund Type Budget Summary" attached hereto as
10	Exhibit A.
11	B. The LOC hereby approves certain revisions to the Branch Chiefs' proposed FY2023 Budget
12	amount for the Office of Hearings and Appeals, as shown in Columns D and E in the
13	"General Fund Comparative Summary" attached hereto as Exhibit B.
14	C. The LOC recommends the changes to the General Fund Budget described in Exhibit C.
15	D. The LOC recommends certain Conditions of Appropriation and Legislative Concerns, as
16	listed in Exhibit D.
17	E. The LOC recommends that certain Unmet Needs for the Office of Hearings and Appeals be
18	included in the FY2023 Comprehensive Budget, as explained in Exhibit E.
19	F. The LOC hereby recommends that the Budget and Finance Committee approve the Office of
20	Hearings and Appeals proposed FY2023 Budget and all Committee recommendations, as set
21	forth in Exhibits A-E.
22	G. As necessary and appropriate, the LOC hereby authorizes the LOC Chair and Vice-Chair to
23	negotiate the LOC's recommendations herein with the Budget and Finance Committee.

25	SECTION FOUR. EFFECTIVE DATE
26	This Act shall become effective as provided in 2 N.N.C. §189(A).
27	
28	SECTION FIVE. SAVING CLAUSE
29	If any portion of this Action is determined invalid by the Navajo Nation Supreme Court, or by
30	a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the

remainder of this Act shall be the law of the Navajo Nation.
