18	SECTION ONE. AUTHORITY	
19	A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council	
20	with oversight authority over the Office of the Auditor General ("OAG"). 2 N.N.C. §300(A);	
21	12 N.N.C. §301(B)(13).	
22	B. Each Oversight Committee, including the Budget and Finance Committee, shall review and	
23	make recommendations regarding the programs under its oversight responsibility, regarding	
24	the Navajo Nation's Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C.	
25	§840(A).

27	SECTION TWO. FINDINGS	
28	A. The Budget and Finance Committee held a meeting and took relevant testimony regarding	
29	the FY2023 Budget for the OAG.	
30	B. During these budget meetings, the Budget and Finance Committee reviewed and considered	

the proposed FY2023	Budget for the	OAG, as	commented	upon by	members	of the	public.

# SECTION THREE. APPROVING AND RECOMMENDING THE FISCAL YEAR 2023 BUDGET FOR THE OFFICE OF THE AUDITOR GENERAL AND RELATED MATTERS

- A. The Budget and Finance Committee hereby approves the FY2023 Budget for the Office of the Auditor General, as detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit A**.
- B. The Budget and Finance Committee hereby approves certain revisions to the Branch Chiefs' proposed FY2023 Budget amount for the OAG, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as **Exhibit B**.
- C. The Budget and Finance Committee recommends certain changes to the General Fund Budget, as described in the attached **Exhibit C**.
- D. The Budget and Finance Committee recommends certain Conditions of Appropriation and Legislative Concerns, as listed in the attached **Exhibit D**.
- E. The Budget and Finance Committee recommends that certain Unmet Needs for the OAG be included in the FY2023 Comprehensive Budget, as explained in the attached **Exhibit E**.
- F. The Budget and Finance Committee hereby recommends that the Navajo Nation Council approve the OAG's FY2023 Budget and all Committee recommendations, as set forth in the attached **Exhibits A-E**.

#### SECTION FOUR. EFFECTIVE DATE

This Act shall become effective as provided in 2 N.N.C. §189(A).

### SECTION FIVE. SAVING CLAUSE

If any portion of this Action is determined invalid by the Navajo Nation Supreme Court, or by a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the remainder of this Act shall be the law of the Navajo Nation.
