19	SECTION ONE. AUTHORITY	
20	A. The Law and Order Committee ("LOC") is a standing committee of the Navajo Nation	
21	Council with oversight authority over the Judicial Branch. 2 N.N.C. §600(A); 2 N.N.C.	
22	§601(C)(1).	
23	B. Each Oversight Committee, including the LOC, shall review and make recommendations	
24	regarding the programs under its oversight responsibility, regarding the Navajo Nation's	
25	Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C. §840(A).

27	SECTION TWO. FINDINGS	
28	A. In accordance with 12 N.N.C. §840(A), the LOC held public hearings and took relevant	
29	testimony regarding the FY2023 Budget for the Judicial Branch.	
30	B. During these budget meetings, the LOC reviewed and considered the proposed FY2023	

Budget for the Judicial Branch, as commented upon by members of the public.

SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2023 BUDGET FOR THE JUDICIAL BRANCH AND RELATED MATTERS

A. The Law and Order Committee hereby approves the FY2023 Budget for the Judicial Branch, as detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit A**.

B. The LOC hereby approves certain revisions to the Branch Chiefs' proposed FY2023 Budget amount for the Judicial Branch, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as **Exhibit B**.

C. The LOC recommends the changes to the General Fund Budget described in Exhibit C.

- D. The LOC recommends certain Conditions of Appropriation and Legislative Concerns, as listed in Exhibit D.
- E. The LOC recommends that certain Unmet Needs for the Judicial Branch be included in the FY2023 Comprehensive Budget, as explained in **Exhibit E**.
- F. The LOC hereby recommends that the Budget and Finance Committee approve the Judicial Branch's proposed FY2023 Budget and all Committee recommendations, as set forth in **Exhibits A-E**.

G. As necessary and appropriate, the LOC hereby authorizes the LOC Chair and Vice-Chair to negotiate the LOC's recommendations herein with the Budget and Finance Committee.

SECTION FOUR. EFFECTIVE DATE

This Act shall become effective as provided in 2 N.N.C. §189(A).

SECTION FIVE. SAVING CLAUSE

If any portion of this Action is determined invalid by the Navajo Nation Supreme Court, or by a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the remainder of this Act shall be the law of the Navajo Nation.
