18	SECTION ONE. AUTHORITY	
19	A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council	
20	with oversight authority over the Office of the Controller. 2 N.N.C. §300(A); 12 N.N.C.	
21	§301(B)(13).	
22	B. Each Oversight Committee, including the Budget and Finance Committee, shall review and	
23	make recommendations regarding the programs under its oversight responsibility, regarding	
24	the Navajo Nation's Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C.	
25	§840(A).

27	SECTION TWO. FINDINGS	
28	A. The Budget and Finance Committee held a meeting and took relevant testimony regarding	
29	the FY2023 Budget for the Office of the Controller ("OOC").	
30	B. During these budget meetings, the Budget and Finance Committee reviewed and considered

1	the FY2023 Budget for OOC, as proposed by the Branch Chiefs and as commented upon by
2	members of the public.

4	SECTION THREE. APPROVING AND RECOMMENDING THE FISCAL YEAR 2023
5	BUDGET FOR THE OFFICE OF THE CONTROLLER AND
6	RELATED MATTERS
7	A. The Budget and Finance Committee hereby approves the FY2023 Budget for the OOC, as
8	detailed in the "Fund Type Budget Summary" attached hereto as Exhibit A.
9	B. The Budget and Finance Committee hereby approves certain revisions to the Branch Chiefs'
10	proposed FY2023 Budget amount for OOC, as shown in Columns D and E in the "General
11	Fund Comparative Summary" attached hereto as Exhibit B.
12	C. The Budget and Finance Committee recommends certain changes to the General Fund
13	Budget, as described in the attached Exhibit C.
14	D. The Budget and Finance Committee recommends certain Conditions of Appropriation and
15	Legislative Concerns, as listed in the attached Exhibit D.
16	E. The Budget and Finance Committee recommends that certain Unmet Needs for OOC be
17	included in the FY2023 Comprehensive Budget, as explained in the attached Exhibit E.
18	F. The Budget and Finance Committee hereby recommends that the Navajo Nation Council
19	approve OOC's FY2023 Budget and all Committee recommendations, as set forth in the
20	attached Exhibits A-E.

22	SECTION FOUR. EFFECTIVE DATE
23	This Act shall become effective as provided in 2 N.N.C. §189(A).

25	SECTION FIVE. SAVING CLAUSE
26	If any portion of this Action is determined invalid by the Navajo Nation Supreme Court, or by
27	a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the
28	remainder of this Act shall be the law of the Navajo Nation.
