PURPOSE: This resolution, if approved, will renew the P.L. 93-639 contract with the Department of Water Resources for the Water Development Program for a five-year period beginning January 1, 2023 and ending December 31, 2027.

| 24 | A. The Resources and Development Committee is a standing committee of the Navajo |
| 25 | Nation Council and is empowered with oversight authority over the Division of |
| 26 | Natural Resources, which includes the Department of Water Resources. 2 N.N.C. § |
| 27 | 500 and 501(B)(1). |
| 28 | B. The Budget and Finance Committee is a standing committee of the Navajo Nation |
| 29 | Council and is empowered to authorize, review, approve and accept agreements, |
| 30 | including contracts and grants between the Navajo Nation and federal authority upon |

the recommendation of the standing committee which has oversight over the division, department or program which has applied for the agreement. 2 N.N.C. §§ 300 and § 301(B)(15).

C. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council and is empowered to authorize, review, approve and accept any and all contracts, grants and associated budgets with the United States, its departments and agencies for the implementation of the Indian Self-Determination and Education Assistance Act, 25 U.S.C. §5301 *et seq.* (P. L. 93-638 as amended), upon the recommendation of the standing committee which has oversight over the division, department or program which has applied for the contract and/or grant. 2 N.N.C. §701(A)(12).

SECTION TWO. FINDINGS

- A. It is in the best interest of the Navajo Nation and its citizens to enter into the Indian Self-Determination and Education Assistance Act, 25 U.S.C. §5301 *et seq.* (P. L. 93-638 as amended) contract, including the Annual Funding Agreement and Scope of Work, attached as **Exhibit A**, with the United States Department of Interior Bureau of Indian Affairs to fund and support the Water Development Program for a five-year term beginning January 1, 2023 and ending December 31, 2027.
- B. The proposed Water Development Program P.L. 93-638 contract, Annual Funding Agreement, and Scope of Work, attached as Exhibit A, has been endorsed by requisite reviewers and is determined legally sufficient and eligible for signature. See Exhibit B.

SECTION THREE. APPROVALS

A. The Navajo Nation hereby approves and authorizes a contract between the Navajo Nation and the United States Department of the Interior, Bureau of Indian Affairs, under 25 U.S.C. § 5301 *et seq.* (P.L. 93-638, as amended), for a five (5) year period beginning January 1, 2023 and ending December 31, 2027 for the Water Development Program as set forth in the documents attached as Exhibit A.

B. The Navajo Nation hereby approves and authorizes the Annual Funding Agreement and Scope of Work for the Water Development Program, for the contract term, as set forth in the documents attached as **Exhibit A**.

C. The Navajo Nation hereby authorizes the President of the Navajo Nation to execute and effectuate the P.L. 93-638 Contract, Annual Funding Agreement, and Scope of Work, provided the terms and conditions in such documents are substantially similar to those approved by this resolution.
