




# **TRAVEL DIRECTIONS**

# Window Rock – Pinon – Mesa Central (MCW)/Kayenta Mine



- 1. Travel West on Hwy 264 to Burnside (34 miles)
- 2. Merge onto Hwy 191 toward Chinle (25 miles)
- 3. Turn left on Indian Route 4 to Pinon (37 miles)
- 4. Turn right on BIA 41 (Navajo Service Route 41) to **Forest Lakes Chapter** (21 miles) (\*see map below for directions from Forest Lake Chapter to Mesa Central Warehouse)





## Window Rock – Kayenta – Mesa Central Warehouse (MCW)/Kayenta Mine

- 1. Travel West on Hwy 264 to Burnside (34 miles)
- 2. Merge onto Hwy 191 (US191-S) to Many Farms (46 miles)
- 3. Turn left on Navajo Route 59 (61 miles)
- 4. Turn left on US 160-E (8 miles) toward Kayenta
- 5. Continue through Kayenta to the west on US-160-E (20 miles)
- 6. Turn left onto Navajo Service Route 41
