16	SECTION ONE. AUTHORITY	
17	A. In 1973, in Resolution No. CF-21-73, the Navajo Nation Council established a retirement	
18	plan scheme for the benefit of Navajo Nation employees and officials.	
19	B. Under its authority delegated by the Council in CF-21-73, the Budget and Finance	
20	Committee originally adopted the "Retirement Plan for Employees of the Navajo Tribe and	
21	Certain Tribal Affiliates" ("Retirement Plan") effective July 1, 1973. BFMY-41-73.	
22	C. The Budget and Finance Committee is authorized to promulgate policies and regulations	
23	concerning fringe benefits for Navajo Nation employees and officials, and to conduct	
24	oversight of the functions of the Department of Retirement Services. 2 N.N.C. §301(B)(8)	
25	and §301(B)(13).	
26	D. As the "Employer" under the Retirement Plan, the Navajo Nation has the right to amend the	
27	Retirement Plan from time to time, as provided in Section 13.01 of the Retirement Plan.

29	SECTION TWO. FINDINGS	
30	A. Since the original version of the Retirement Plan was adopted in 1973, the Navajo Nation	

1	Council, the Budget and Finance Committee, and the Human Services Committee have
2	approved several amendments to the Retirement Plan. Resolution Nos. BFMA-56-74,
3	BFMY-198-77, CMY-26-79, BFJY-101-85, BFJN-71-86, BFS-56-90, BFMY-25-91, BFS-
4	98-02, BFMA-34-03, BFMA-05-08, BFCO-16-09, HSCD-13-10, BFJY-16-19, BFO-34-19,
5	and BFMY-13-21.
6	B. In RPAC-03-22, the Retirement Plan Administration Committee approved, and recommends
7	to the Budget and Finance Committee the approval of, the "RETIREMENT PLAN FOR
8	EMPLOYEES OF THE NAVAJO NATION AND PARTICIPATING AFFILIATES -
9	Amended and Restated - Effective January 1, 2023" ("Amended Plan"). EXHIBIT 1.
10	C. If approved, the Amended Plan will change the definition of "earnings" for Navajo Nation
11	Council Delegates, as shown in EXHIBIT 2 , page 5, as follows:
12	Section 1.20 "Earnings" shall mean, for any period, base salary or base wages
13	received from the Employer for that period. Earnings shall exclude
14	overtime, bonuses, etc. Earnings shall include contributions made
15	by an Employer pursuant to salary reduction elections of an
16	Employee that are not includible in gross income of the Employee
17	under Code Sections 125 or 402(a)(8) (i.e., cafeteria plan or 401(k)
18	contributions). For Benefit Commencement Dates after October 1,
19	2000, hourly pay rates used to determine any Accrued Benefit shall
20	not be less than \$2.01. Solely with respect to Delegates of the
21	Navajo Nation Council serving in such role on or after January 1,
22	2023, "Earnings" shall mean Compensation up to \$55,000 for any
23	12-month period in which such individual served as a Delegate.
24	D. The Department of Retirement Services recommends that the Amended Plan become
25	effective as of January 1, 2023 to give the Department time to implement the proposed
26	changes.
27	E. The Budget and Finance Committee, pursuant to its authorities under 2 N.N.C. §301(B)(8)
28	and §301(B)(13), its delegated authority under CF-21-73, and the authority of the Navajo
29	Nation under Section 13.01 of the Retirement Plan, finds it is in the best interest of the Navajo
30	Nation to approve the proposed Amended Plan, with an effective date of January 1, 2023.

SECTION THREE. APPROVAL

The Budget and Finance Committee hereby approves and adopts the "RETIREMENT PLAN FOR EMPLOYEES OF THE NAVAJO NATION AND PARTICIPATING AFFILIATES -Amended and Restated - Effective January 1, 2023" attached hereto as **EXHIBIT 2**.

SECTION FOUR. EFFECTIVE DATE

This Action, and the "RETIREMENT PLAN FOR EMPLOYEES OF THE NAVAJO NATION AND PARTICIPATING AFFILIATES - Amended and Restated - Effective January 1, 2023" attached hereto as **EXHIBIT 2**, shall become effective as of January 1, 2023.

SECTION FIVE. SAVING CLAUSE

If any portion of this Action is determined in valid by the Navajo Nation Supreme Court, or by a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the remainder of this Action shall be the law of the Navajo Nation.
