19	SECTION ONE. AUTHORITY	
20	A. The Resources and Development Committee of the Navajo Nation Council is empowered to	
21	exercise oversight authority over Chapter activities. 2 N.N.C. §500(C).	
22	B. The Budget and Finance Committee of the Navajo Nation Council is empowered to review	
23	and recommend to the Navajo Nation Council the budgeting, appropriation, investment and	
24	management of all funds, and to coordinate and review all fiscal, financial and investment	
25	activities of the Navajo Nation. 2 N.N.C. §301(B)(2) and §301(B)(5).	
26	C. The Navajo Nation Council approved Resolution No. CAP-35-18, titled: "Adopting the	
27	Síhasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14, as	
28	Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12 N.N.C. §§	
29	810 (F), 820 (I) And (M) And 860 (C) Relating to the Capital Improvement Budget and the	
30	Capital Improvement Process." CAP-35-18 is incorporated herein by reference.	

D. Section 4(C) of CAP-35-18 specifically provides: "A chapter project, powerline, or waterline project may be changed, including the year funded, or added to Exhibits A through E with the concurrence of the Delegate representing the chapter's Council District and the approvals of the Resources and Development Committee and Budget and Finance Committee, as long as such project has been certified as construction-ready by CPMD or NTUA and the total Síhasin Funding for the District does not exceed \$4,166,666.67."

SECTION TWO. FINDINGS

- A. The amount of \$150,000 for the Pinon Chapter's "Communications Systems Upgrade" Project was approved in Exhibit D to CAP-35-18. The CAP-35-18 Exhibit D showing the Pinon Chapter Project No. D-161 is attached hereto as **EXHIBIT 1**.
- B. The amount of \$21,660 for the Pinon Chapter's "Perimeter Fencing-Construction" Project was approved in Exhibit D to CAP-35-18. The CAP-35-18 Exhibit D showing the Pinon Chapter Project No. D-162 is included under the attached EXHIBIT 1.
- C. The amount of \$10,000 for the Pinon Chapter's "Clearances for Withdrawal of Land" Project was approved in Exhibit D to CAP-35-18. The CAP-35-18 Exhibit D showing the Pinon Chapter Project No. D-163 is included under EXHIBIT 1.
- D. On behalf of the Pinon Chapter, the Division of Community Development Capital Projects
 Management Department ("CPMD") has submitted three Síhasin Project Amendment
 Certification Forms describing the Pinon Chapter's requested changes to the three Projects
 Nos. D-161, D-162, and D-163. EXHIBIT 2.

E. The Pinon Chapter wishes to move all funding approved in CAP-35-18 for these three Projects from Funding Year 1 to Funding Year 3. The Chapter also wishes to change the scope of work for the D-162 Project from "Perimeter Fencing-Construction" to "Plan, Design, Equipment, and Construction." **EXHIBIT 2**.

F. The three Síhasin Project Amendment Certification Forms attached hereto all show the signature of the Navajo Nation Council Delegate for the Pinon Chapter, in accordance with CAP-35-18 Section 4(C).

G. As required by CAP-35-18 Section 4(C), the new projects have been certified by CPMD as construction-ready and the total Síhasin funding for the Council District will not exceed

H. The Pinon Chapter, in Resolution No., PIN-22-43, requests the changes to it Projects, as explained herein. EXHIBIT 3.

SECTION THREE. APPROVAL OF AMENDMENT TO CAP-35-18 EXHIBIT D

- A. The Navajo Nation hereby approves a change to Resolution No. CAP-35-18, Exhibit D, Project No. D-161, by moving the \$150,000 in approved funds from Funding Year 1 to Funding Year 3.
- B. The Navajo Nation hereby approves a change to Resolution No. CAP-35-18, Exhibit D, Project No. D-162, by moving the \$21,660 in approved funds from Funding Year 1 to 12 Funding Year 3.
- C. The Navajo Nation hereby approves a change to Resolution No. CAP-35-18, Exhibit D, 14 Project No. D-163, by moving the \$10,000 in approved funds from Funding Year 1 to 15 16 Funding Year 3.
 - D. The Navajo Nation hereby approves a change to Resolution No. CAP-35-18, Exhibit D, Project No. D-162, by approving a change to the scope of work for the D-162 Project from "Perimeter Fencing-Construction" to "Plan, Design, Equipment, and Construction" as shown in EXHIBIT 2.
 - E. The Síhasin Fund may be reimbursed the funds reallocated herein, from funds available to the Navajo Nation from any and all state, federal, or other sources.
