22	SECTION 2. FINDINGS
23	A. The Division of Natural Resources Navajo Forestry Department has requested
24	amendments to its Plan of Operation, attached as Exhibit A. The Navajo Forestry
25	Department latest Plan of Operation was approved by Resolution RDCO-79-16,
26	Exhibit E. Resolution RDCO-79-16 with its Exhibit E are attached as Exhibit B .
27	B. The Navajo Forestry Department requests the amendment of its Plan of Operation to
28	increase its authorities, duties and responsibilities to include the ability to administer
29	the carbon offset revenues under a Forest Carbon Fund Management Plan. These
30	new duties arise out of the Navajo Nation Council's Resolution CAP-17-22 which

- approved the Carbon Development and Marketing Agreement between the Navajo Nation and Bluesource, LLC. Resolution CAP-17-22 is attached as **Exhibit C**.
- C. The Executive Official Review form for the amendments to the Navajo Forestry Department Plan of Operation is attached as **Exhibit D**.

SECTION 3. AMENDING THE OPERATION FOR THE NAVAJO FORESTRY DEPARTMENT
